



RAMSrent End-User License Agreement

IMPORTANT-READ CAREFULLY: This End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single legal entity) and the manufacturer ("Manufacturer") of the software system named ("RAMSrent"). The SOFTWARE includes the RAMSrent software and website ("Site"), and may include associated media, printed materials, "online," or electronic documentation and Internet based services.

Prior to using the SOFTWARE, please read these terms and conditions. At any time and from time to time, the Manufacturer may modify the terms and conditions of access and use of the SOFTWARE. Accordingly, please continue to review these terms and conditions of service whenever accessing or using the SOFTWARE. Any terms and conditions proposed by you which are in addition to or which conflict with these terms and conditions of service are hereby rejected by Paul Enterprises, LLC and shall be devoid of all force and effect allowed by applicable law.

SOFTWARE PRODUCT LICENSE

1. **GRANT OF LICENSE.** Manufacturer grants you the following rights, provided you comply with all of the terms and conditions of this EULA:

* **Reservation of Rights.** Manufacturer, Paul Enterprises, LLC, hereinafter ("PEI") reserves all rights not expressly granted to you in this EULA.

2. **DESCRIPTION OF OTHER RIGHTS AND LIMITATIONS.**

* **Internet-Based Services Components.** The SOFTWARE contains components that enable and facilitate the use of certain Internet-based services. You acknowledge and agree that PEI may automatically check the version of the SOFTWARE and/or its components that you are utilizing and may provide upgrades or supplements to the SOFTWARE.

* **Additional Software/Services.** The terms of this EULA apply to updates, supplements, add-on components, or Internet-based services components of the SOFTWARE ("Supplemental Components") that Manufacturer, PEI may provide to you or make available to you after the date you initially access the SOFTWARE, unless other terms are provided along with such Supplemental Components.

Manufacturer, PEI reserves the right to discontinue any Internet-based services provided to you or made available to you through the use of the SOFTWARE should relevant remunerations and/or payments not be made by you to PEI.

This EULA does not grant you any rights to use RAMSrent components contained in the SOFTWARE to develop a software application that uses similar technology.

* **Limitations on Reverse Engineering, Decompilation and Disassembly.** You may not reverse engineer, decompile, or disassemble the SOFTWARE, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

* **Termination.** Without prejudice to any other rights, PEI may cancel this EULA if you do not abide by the terms and conditions contained herein. Termination can also occur due to non-payment of all relevant fee(s).

* **Trademarks.** This EULA does not grant you any rights in connection with any trademarks or service marks of Manufacturer.

3. **FINANCIAL TRANSACTION TERMS**



PEI provides its users with access to an Internet-based credit card service and on-line electronic checking service to Affiliates, rental property owners, rental property managers and their respective tenants, which facilitates various electronic payments for monthly rents, periodic rents, and other fees and charges related to making rent payments. You, as the tenant of an Affiliate, are eligible to use these web-based services to pay your rent and any related fees covered under our Service Level Agreement with our Affiliates. Your credit card, on-line electronic checking payments made through RAMSrent will be remitted to the appropriate Affiliate in accordance with our Service Level Agreement. You will receive a timely written confirmation from PEI acknowledging the RAMSrent receipt of credit card or on-line electronic checking payments. You must obtain access to the World Wide Web and/or Internet in order to use the SOFTWARE, either directly or through other devices that access web-based content. You must also pay any service fees associated with such access.

4. INTELLECTUAL PROPERTY RIGHTS. All title and intellectual property rights in and to the SOFTWARE (including but not limited to any images, photographs, animations, video, audio, music, text and "applets," incorporated into the SOFTWARE), the accompanying printed materials, and any copies of the SOFTWARE, are owned by PEI.
